The Maryland Green Registry is a group of organizations working toward a sustainable Maryland. It began in 2009 as a means to showcase businesses' and organizations' positive environmental practices. By joining the Maryland Green Registry, your agency can show its commitment to the environment and can save money simultaneously. Collectively, members have saved over \$79 million annually through their environmental practices.

State agencies are doing a good job coordinating their recycling activities. The Maryland Green

State Government Mandated to Recycle 30 Percent in 2014

During the 2012 Maryland General Assembly session, legislation passed that increased the amount of waste required to be recycled by State agencies to 30 percent in 2014, with a goal of 40 percent for each State Agency by 2015.

In 2013, eleven State Agencies recycled at least 30 percent of their

waste and Maryland State Government, as a whole, exceeded the minimum rate requirement and recycled 31.6 percent of the waste it generated.

The following State agencies reached a recycling rate of at least 30 percent in 2013:

- Comptroller of Maryland;
- Dept. of Assessments and Taxation;
- Dept. of Budget and Management;

Registry provides the perfect vehicle through which you can share your agency's success stories and results, post your agency's recycling activities and initiatives, and observe what other State agencies are doing to increase their recycling and save energy.

To join, you will need to: share at least five environmental best practices in place at your agency; share at least one measurable environmental result; and update your profile at least once every three years.

The following State agencies are already members of the Maryland Green Registry:

- MD Automobile Insurance Fund;
- Dept. of Agriculture;
- Dept. of General Services;
- Dept. of Housing and Community Development;
- Dept. of Natural Resources;
- Dept. of the Environment;
- Dept. of Transportation;
- MD Higher Education Commission;
- Motor Vehicle Administration;
- Port Administration;
- State Highway Administration; and
- Maryland Transportation Authority.

A new and exciting Green Registry program is the Compost Challenge which promotes the collection of food scraps for composting. According to the United States Environmental Protection Agency's 2012 waste generation data, food scraps account for 21.1 percent of trash thrown away on an annual basis. Food is the largest percent-

age of waste type that is disposed that could be recycled.

The Maryland Green Registry Compost Challenge was created to highlight the growing number of organizations that are starting to compost. The Compost Challenge will run through June 2015.

If your agency is not yet collecting food scraps, consider conducting a pilot collection program to give you an idea of the volume that may be collected in the future. Several businesses are available that can collect your food scraps from a central location, such as your loading dock, and haul them to a composting facility. Or you may choose to compost directly on site if you have the space to do so. Please contact the Maryland Department of the Environment (MDE) for more information about regulatory requirements related to composting and to locate businesses that may assist you.

The following State Agency Green Registry members are already registered for the Compost Challenge and reporting that they are composting:

- Dept. of General Services;
- Dept. Of Environment;
- State Highway Administration;
- Towson University;
- University of Maryland Baltimore County;
- University of Maryland University College; and
- University of Maryland College Park.

Great job!

Did you know that MDE Headquarters achieved a 70.8 percent recycling rate in 2013? Adding food scraps collection for composting increased MDE's recycling rate by 21.3 percent points over the

2012 rate of 49.5 percent and your organization can do the same!

We encourage you to take the Compost Challenge, compete against other State agencies, and see if your organization can be the "best of the best".
