Mayor and City Council of Baltimore, 100 North Holiday Street, Baltimore, MD 21202 applied for renewal of the permit to discharge an average of 180 million gallons per day of treated domestic wastewater from the Back River Wastewater Treatment Plant located at 8201 Eastern Avenue, Baltimore, MD 21224 to the Back River (Outfall 001) and Bear Creek (Outfall 002) both designated as Use II - Tidal Fresh Waters, protected for Migratory Spawning and Nursery Use, Shallow Water Submerged Aquatic Vegetation Use, and Open Water Fish and Shellfish.

The notice of application received was published on August 16, 2023, and August 23, 2023, in The Sun.
